REGULAR CITY COUNCIL MEETING CITY OF SHELL LAKE September 12, 2016

Schultz moved, seconded by Edlin, to approve the minutes from the Regular City Council meeting held on August 8, 2016. Motion carried.

Public Comment: None.

Mitch Brown presented the Public Works Director's report. Peterson thanked the Public Work's crew for all the work they did during the Town & Country Day's event.

Wilson presented the Police Chief report. Peterson thanked the Police for all the work they did during the Town & Country Day's event.

Peterson presented the Zoning Board of Appeals minutes.

Peterson presented the minutes from the Plan Commission. Peterson presented a letter received from Lynn and Dan Hubin opposing the Plan Commission recommendation. Schultz moved, seconded by Jenderny, to approve the Conditional Use Permit for Anderson Addition (CSL) PT LOT 2 & 3 LOT 1 CSM V 18 P 43 V 434 P 802-803 WD to the Industrial/Business Park (112 Anderson Ave) to acquire the property for the purpose of constructing and operating an Enterprise Center. Northwest Regional Planning Commission will be responsible for management and operation of a mixed-use. multi-tenant Enterprise Center that meets the uses as specified in Zoning Ordinance Section 13-1-51 as of September 1, 2016. Northwest Regional Planning Commission will be responsible for ensuring all tenants occupying the Enterprise Center meet the Conditional Use classifications of Zoning Code Section 13-1-51 (c)(1, 2, 3, 4, 5, 9, 10, 11, 12, 13, 14, 17, 18, 22). Zoning District: Industrial-Light (I-2). Zoning Ordinance Section 13-1-82 through 13-1-90 Conditional Uses, with the contingency that successful funding of the program is completed by September 30, 2017. Roll Call vote was taken: Jenderny – Yes, Leckel – Yes, Schultz – Yes, Edlin – Yes, Sheldon – Yes, Andrews – Yes. The motion carried unanimously.

Peterson presented the Library minutes.

EXECUTIVE/HUMAN RESOURCES: Peterson announced the committee will be holding a meeting in September. Agenda pending.

PUBLIC WORKS ADMINISTRATION: Schultz presented the Public Works minutes. Schultz updated the Council on the ATV campground.

Jenderny moved, seconded by Andrews, to approve the Temporary Class "B" Retailer's Licenses for Theatre in the Woods and Potter's Shed. Motion carried.

UNFINISHED BUSINESS: Peterson asked if the shared calendar request had been completed. The answer was no. Peterson requested the addition of committee minutes to the City web site be researched.

Shelton moved, seconded by Andrews, to approve resolution 16-09. Upon unanimous vote, the motion carried.

Shelton moved, seconded by Andrews to approve the Wisconsin Department of Revenue County and Municipality Agency Agreement For Tax Refund Interception. Upon unanimous vote, the motion carried.

Andrews moved, seconded by Jenderny, to approve Washburn County request to open the section of County Road D between Old County Road D and the Wild Rivers Trail at the intersection of County Road D and Hwy 63, to ATV traffic. Upon unanimous vote, the motion carried.

MAYOR'S REPORT: Peterson thanked the Shell Lake High School Football Team for their recent cleaning of the City beach area. Peterson thanked the Town & Country Day's Committee for all of their work in making the event such a huge success.
