REGULAR CITY COUNCIL MEETING CITY OF SHELL LAKE January 9, 2023

Mayor Sally Peterson called the meeting to order at 7:00 p.m. Council members present were Stephen Smith, Mike Andrews, Brian Carlson, Dan Harrington, Ken Schultz and Deb Nebel. Rowie Hansberger and Rob Anderson were absent. Andy Eiche, Regan Kohler, Mitch Brown, David Wilson, Bryan Rydberg, Dan Rayman, Mike Mayne, Patricia Mayne, Brad Pederson, Mary Dunbar and Jon Haley were also present.

Smith moved, seconded by Schultz, to approve the council minutes from December 12, 2022. Motion carried unanimously.

Public Comment: Brad Pederson and Andy Eiche presented Mary Dunbar with an award of excellence for 25 years of service as the City of Shell Lake Chief Election Inspector. The award came from Governor Evers. Pederson and Eiche both thanked Dunbar for all of her excellent years of service to her community.

Jon Haley voiced his opposition to the Hangar 97 proposal. He requested the community be informed of any further meetings relating to the matter.

Mike Mayne voiced opposition to the Hangar 97 proposal.

Patricia Mayne voiced opposition to the Hangar 97 proposal, and distributed a petition and letter they would be sending out to approximately 200 Shell Lake residents.

Eiche requested the council vote by consensus to allow the Administrator to continue the services of Vincent Escamilla as a Limited Term employee at his current rate of pay. By consensus, the council agreed.

Eiche requested to post for a full-time police officer to replace the vacated spot held by Vincent Escamilla. Schultz moved, seconded by Carlson, to have the City Administrator begin the posting for a full-time police officer position. Upon unanimous vote, the motion carried.

Schultz moved, seconded by Andrews, to adjourn at 8:05 p.m. Meeting adjourned.
